Strategic Plan and District Updates

Pillar 3: Engagement and Collaboration

- Parent Portal and LAUSD Mobile App: The upgraded version of the Parent Portal will be
 made available to families this month and will also go live in the upgraded version of the
 LAUSD Mobile App 3.0. The Parent Portal will evolve to include the district's new Individual
 Acceleration Plan.
- School Volunteer Program Management System: The site has included new efficiencies that inform prospective volunteers and school employers pending actions missing in order to approve the application. To date our office has assisted school sites with processing over 12,000 volunteer applications. The team leads are also to date in processing applications processed by the school site.
- The Family Academy Course Catalogue and Equity Course Pathways: The Family Academy continues to build great momentum. Evaluations completed by participants have offered comments and scores showing participants are learning information to act in their child's education, to be civically engaged and to connect to valuable resources. In person learning and engagement will continue through webinars and in person opportunities hosted with our Region office PACE teams.
- Professional Development: Regions hosted professional development convenings for
 their school teams where principals, assistance principals, coordinators, Parent and
 Family Center, and office staff are invited to complete clinics focused on family
 engagement. We are continuing to offer ongoing clinics and Community of School follow
 up to help school sites with systems that support welcoming environment, volunteer
 processing, Parent Portal registration and leading budget consultations with and for
 families.

Responsibilities Assigned to the CAC

The CAC shall advise the school district governing board on at least the following tasks:

- 1. Advising the policy and administrative entity of the special education local plan area regarding the development, amendment, and review of the local plan. The entity shall review and consider comments from the community advisory committee.
- 2. Recommending annual priorities to be addressed by the plan.
- 3. Assisting in parent education and in recruiting parents and other volunteers who may contribute to the implementation of the plan.
- 4. Encouraging community involvement in the development and review of the local plan.
- 5. Supporting activities on behalf of individuals with exceptional needs.
- 6. Assisting in parent awareness of the importance of regular school attendance.

Supporting community involvement in the parent advisory committee established pursuant to Section 52063 to encourage the inclusion of parents of individuals with exceptional needs to the extent these pupils also fall within one or more of the definitions in Section 42238.01
