



NOTICE OF AVAILABILITY OF A DRAFT ENVIRONMENTAL IMPACT REPORT

PROJECT TITLE: San Pedro High School Comprehensive Modernization Project

SUBJECT: Notice of Availability of a Draft Environmental Impact Report

Notice is hereby given that the Los Angeles Unified School District (LAUSD), as Lead Agency for the San Pedro High School Comprehensive Modernization Project, has prepared a Draft Environmental Impact Report (Draft EIR) pursuant to the California Environmental Quality Act (CEQA) (California Public Resources Code [PRC], Division 13, Section 21000 et seq. [CEQA Statute] and the California Code of Regulations [CCR], Title 14, Division 6, Chapter 3, Section 15000 et seq. [CEQA Guidelines]). The purpose of this notice is to solicit comments regarding the content of the Draft EIR.

PROJECT LOCATION: The 22.90-acre San Pedro HS campus is located at 1001 West 15th Street, in the community of San Pedro, in the City and County of Los Angeles, California.

PROJECT DESCRIPTION: The proposed Project would include renovations, modernizations, and new construction at San Pedro HS. The Project would include: the construction of a Band and Industrial Arts Building, a Central Plant, Lunch Shelters, and a new Administration, Food Services, and Classroom Building; modifications and/or upgrades to the existing Administration Building, the Physical Education Building (Old Gym), the Home Economics Building, Classroom Building 1, and Classroom Building 2; site-wide improvements to accessibility and site-wide upgrades to infrastructure; and the demolition and/or removal of the Industrial Arts Building, Metal Shop Building, and Lunch Shelter/Food Service Unit, four portable (relocatable) buildings, and one modular building.

POTENTIAL ENVIRONMENTAL EFFECTS: The District evaluated the potentially significant effects of the Project related to Air Quality, Cultural Resources, Energy, Greenhouse Gas Emissions, Noise, Pedestrian Safety, and Transportation and Traffic. The Draft EIR determined that the proposed project would not result in any significant environmental impacts related to these issues.

PUBLIC REVIEW PERIOD AND DOCUMENT AVAILABILITY: The Draft EIR will be available for review during the 45-day public review period from **May 17, 2018 to July 2, 2018 (excludes Memorial Day)**. A copy of the Draft EIR is available for review at:
