



TESTING UPDATES

SPRING 2023 TESTING CALENDAR AND SUBMISSION OF TESTING WINDOWS

[REF-126505.1, 2022-23 State and National Mandated Testing Calendars, dated December 19](#), provides the revised State and National testing calendars for the 2022-23 school year. The table below indicates the testing window for each assessment. Note that the CAASPP testing window for some early start schools is different (See Attachment B of REF-126505.1)

REF-126505.1, which replaces REF-126505, provides the revised testing windows for the 2023-23 school year. Schools must schedule all regular and make-up testing for each program on the specific dates or within the revised District testing window(s). Coordinators for each testing program should review REF-126505.1 and confirm that testing for their schools has been scheduled in accordance with the revised testing windows.

NEW FOR SPRING 2023!

The CAASPP and ELPAC coordinators at each school are responsible for submitting to the Student Testing Branch their testing calendar. Specifically, the CAASPP and ELPAC Coordinators will indicate each date the school will administer Summative CAASPP and Summative ELPAC assessments. The [Quick Guide: Testing Calendar Submission](#) provides step-by-step instructions for submitting the testing calendar for the school through the STB Portal.

The information provided by the CAASPP and ELPAC coordinators at each school will be shared with Region Administrators, ITD, MMED, SpEd, and other District offices so each office can strategically plan support and allocate resources. The testing windows are also provided to the office of the Superintendent as needed.

The ELPAC Calendar will be available for use on 1/20/23 in the STB Portal. The CAASPP Calendar will be available on 1/24/23. The CAASPP/ELPAC Coordinator may update the testing calendar for their school at any time. However, the system will allow changes to future dates only. Any dates in the past, become part of the school's official testing window.
