**Position Offered:** Academic Pathway Advisor – [West Valley OC / Reseda CAS](#)

**Salary:** The salary will be based on the current negotiated Teacher Hourly Rate schedule.

**Job Description:** The Academic Pathways Advisor provides academic program support by motivating cohorts of students toward successful completion of college and career pathway requirements; collaborating with the Assistant Principal, Adult Counseling Services (APACS), with assessment, orientation, recordkeeping, and data review; communicating and working with other Division programs and local/regional partners (K-12, Community College, etc.); and collaborating with administrators and teachers as an instructional leader within a professional learning community. Additionally, the advisor assists in the implementation of the Adult Education Block Grant (AEBG) regional plan and supports program performance under the Workforce Innovation and Opportunity Act (WIOA). The Advisor reports directly to the Principal or designee.

**Duties:**

- Provide comprehensive student support: initial assessment administration and interpretation (TABE, CASAS, Pre-HSE, and student writing samples), program orientation, Individualized Student Plan development and maintenance, and ongoing systematic support for designated cohorts of students.
- Assume a leadership role in the school's data-driven professional learning community: facilitate regular department meetings to build instructional capacity and foster collaboration, deliver relevant PD (standards-based learning, contextualized and differentiated instruction, academic and career pathways, assessment, community college system, etc.), support teachers who request assistance, and mentor new and substitute teachers.
- Advocate for academic programs within the school as well as to community stakeholders and partner organizations: deliver college and career pathway presentations to students, faculty, and other stakeholders and communicate and collaborate with local K-12/community college counselors and YouthSource/WorkSource case managers to support seamless transitions and accelerated student progress.
- Attend all Division sponsored in-services and all applicable meetings.
- Perform other related duties as assigned.

**Minimum Qualifications:**

- California Credential authorizing assignment to teach adults
- Three years of adult academic (ABE and/or ASE) teaching experience
- Ability to travel to multiple locations on a given day

*All minimum requirements must be met on or before the filing deadline. It is the responsibility of the applicant to ensure that documentation of minimum requirements is on file with the Human Resources.*

**Preferred Qualifications:**

- Knowledge of model standards, course outlines, and competency-based instruction
- Knowledge of college and career pathways

- Experience creating and conducting professional development
- Experience building partnerships and collaborating across programs and systems
- Strong written and verbal communication skills
